

1. Instructions, prizes and information on how to enter form part of these conditions of entry. By entering, entrants accept these conditions of entry.
2. The Promoter is Australian Football League, ABN is 97 489 912 318, address is 140 Harbour Esplanade, Docklands, Victoria, 3008.
3. Entries are open to all residents of Victoria, excluding employees of Ticketmaster and the Australian Football League, their immediate families or any agents including other advertising, marketing or promotional firms associated with this competition ("Eligible Entrants").
