

Conditions of Entry – Book Tickets for your chance to Win the Ultimate London Experience

1. Instructions, prizes and information on how to enter form part of these conditions of entry. By entering into or participating in the competition, entrants accept these conditions of entry.
2. The Promoter is AKA Promotions (Australia) PTY LTD (ABN 83 13 014 5603) of Suite 511, 410 Elizabeth Street, Surry Hills 2010
3. The competition begins at 12:00am (Sydney time) on 05/06/2015 and concludes at 11:59pm (Sydney time) on 13/07/2015
4. Entry is open to all residents of Australia.
5. The Major prize is 2 return economy class tickets with Qantas from any Capital Australian city to London, 5 night's accommodation at the luxurious 5-star Sofitel London St James, tickets to see Les Miserables, celebrating thirty years at the Queens Theatre and airport transfers. The major prize is valued at \$9,500. The prize is not transferable or exchangeable and cannot be taken as cash. The Promoter reserves the right to change the prize to one of equal or greater value at any time if the prize becomes unavailable.
6. Accommodation is valid for 5 nights including 8th October 2015, or if for some reason the winner was unable to travel at that time, the hotel will extend validity for a 12 month period with booking dates subject to availability.

18. Entrants personal information will be handled by the Promoter in accordance with the Promoter's Privacy Policy. Any personal information collected will be used by the Promoter for the purpose of conducting the competition (including, without limitation, for the purpose of issuing the prize to winner). Personal information may be disclosed to organisations, contractors and agents associated with the competition (including but not limited to the person or organisation providing the prize).
