

# THE CRYSTALS MEET & GREET COMPETITION Terms & Conditions

#### General

- 1. By participating in the Crystals Meet and Greet promotion (Promotion), you will be deemed to have: (a) accepted these terms and conditions; and (b) expressly consented to our use of your personal information under the Privacy Act, Spam Act and other related communication and privacy legislation for marketing and other Kedron-Wavell Services Club business purposes.
- 2. The promoter is Kedron-Wavell Services Club ABN 76 860 492 483 of 375 Hamilton Road, Chermside QLD 4032 (Promoter).
- 3. The Promotion commences at 9am (AEST) on Tuesday, 29<sup>th</sup> December 2014 and entries close at midnight Tuesday, 30<sup>th</sup> June 2015 (Promotional Period).

#### **How to Enter**

- 5. To enter this Promotion, you must during the Promotional Period purchase online via the Tickemaster page or directly from Kedron-Wavell Services Club a ticket to the Crystals 'And Then He Kissed Me' concert being held at Kedron-Wavell Services Club, Chermside on Saturday, 1<sup>st</sup> August at 7pm (Concert).
- 6. Only one (1) entry per entrant is permitted.
- 7. This is a game of chance and skill plays no part. The Promoter's decision is final and no correspondence will be entered into with entrants.

### Eligibility

- 9. Employees of the Promoter and its Related Bodies Corporate (as this term is defined in the Corporations Act) and such employees' immediate family members are not eligible to enter.

## **Limitation of Liability**

This clause does not affect any rights a consumer may have which are unable to be excluded under Australian law.
